2. Where compliance with **AS1670** - Fire Detection, Warning Control and Intercom Systems and / or **AS3786** - Smoke alarms using scattered light, transmitted light or ionization, the Building Code of Australia and / or other applicable legislation and Australian Standards pertaining to fire alarm equipment is required, it is the sole responsibility of the customer to ensure compliant installation and servicing are carried out by others in addition to any smoke alarm/s installed by Chubb.
3. All smoke alarm detection equipment installed by Chubb must be serviced in accordance with the manufacturer's specifications, and it is the responsibility of the customer to arrange such servicing. Chubb, on the written request of the customer, may arrange servicing of the smoke alarm detection equipment for an additional fee.
4. The smoke alarm detection equipment sold, installed and serviced by Chubb under this agreement is not lifesaving equipment and:
 - (a) must not be relied on by the customer for the purpose of meeting any obligation required by the legislation in paragraph 2 (above);
 - (b) may not be relied upon by the customer for insurance purposes; and
 - (c) it is the responsibility of the customer to confirm the legal requirements applicable to their premises, together with any additional requirements of their insurer.
5. Any Fire Brigade charges are the sole responsibility of the customer and are not the responsibility of Chubb;
6. Chubb is not responsible for existing non-compliant smoke detectors or smoke detectors past their life expectancy; and
7. Ceiling fans, air conditioners or any other factors (including environmental factors) that alter the airflow near a smoke alarm, will reduce its functionality.
